

# Towards a comprehensive recognition of the electrohypersensitivity in Europe?

Is the school a source of electrosensitive people?

The commemorative event for the International Day against Electromagnetic Pollution which was held at the Office of the European Parliament in Madrid



This commemorative event for the International Day against Electromagnetic Pollution addressed this the environmental issue from scientific, social and European political-institutional points of view, emphasizing on the following aspects:

- The <u>International EMF Scientist Appeal</u> (May 11, 2015) to the UN, UN Member States and the WHO requesting they adopt more protective exposure guidelines for electromagnetic fields (EMF) and wireless technology in the face of increasing evidence of risk.
- The opinion on electromagnetic hypersensitivity adopted on 7 January, 2015 by the Section for Transport, Energy, Infrastructure and the Information Society (TEN) of the European Economic and Social Committee (EESC) recognizing the basic demands of the electrosensitive people (recognition as Functional Disability and Environmental Disease, white zones,...) and basic protection measures for the protection of the general public, particularly of the most vulnerable groups (as avoid connecting to wireless in schools). However, the opinion was not passed in EESC plenary causing an EESC scandal: the organised civil society found evidence of serious conflict of interest and filed a complaint with the European ombudsman, which has already opened an inquiry.
- The protectionist measures of the EMF exposure (particularly in infant-juvenile population), requested by institutions as the European Parliament (2008, 2009), the European Environment Agency (2007, 2009, 2011, 2013) and the Parliamentary Assembly of the Council of Europe (Resolution 1815/2011).
- The open debate on child and adolescent vulnerability and lack of protection against the deployment of wireless technologies in education, in favour of the <u>Schools without Wi-Fi</u> in the same way as schools free of tobacco or junk food.
